

Expanded SFI 2024

You can apply for an SFI agreement if:

- you're a farmer or land manager with 'management control' of the land you want to enter into an agreement
- your land is eligible for the SFI actions you select

Make sure all your **land is registered** with the RPA and has the correct land use (such as permanent grassland, temporary grassland, arable) including registering hedges, farmyards, barns, woodland, etc.

SFI agreements will usually last for either 3 or 5 years (ie Hay making 5 yrs).

There are 2 types of actions in the expanded SFI offer:

- SFI actions which you can apply for without specialist advice or prior endorsement this is most of the actions
- 'endorsed' SFI actions for certain priority habitats or species and heritage features, which require prior endorsement from Natural England or Historic England

Expressions of Interest (EOIs) can be made to apply early for the new Expanded SFI offer – from where you will be invited to apply. The RPA are opting for a phased rollout to test the system.

Ending your agreement early – (from May 2024 website and still on 5th August website)

BUT - (This was published under the 2022 to 2024 Sunak Conservative government)

The RPA may allow you to end your agreement early to move to SFI or CS Higher Tier.

If you have a CS Mid Tier or HLS agreement, from September you'll be able to end your existing agreement early to apply for a SFI agreement. You may also be able to apply for a CS Higher Tier agreement this winter, with the first agreements starting from early 2025. You will not be able to end your existing agreement before September.

You'll be able to end your existing agreement either:

• at the end of your current agreement year and receive the full payment due for that year (subject to meeting the requirements of your agreement)

• before the end of your current agreement year, but not receive payment for the part of the current agreement year you've already completed.

Notes

'limited area' actions must not be more than 25% of the total agricultural area of your farm.

Later in 2024, Defra will introduce:

- an educational access action, which will pay you to provide educational tours of your farm or woodland
- more endorsed SFI actions for farmland wildlife and habitats on grassland, heritage, wood pasture, orchards, coastal habitats and waterbodies

Details of these additional SFI actions will be published in summer 2024.

Capital Grants – The agri-environment capital grants offer has been available since January 2024. As of 5th August 2024 a few new items have been added -

AF1: Plant an agroforestry woodland tree
AF2: Plant an agroforestry fruit tree
AF3: Supplement: Species diversity bonus
TE6: Tree guard (tube and mesh)
TE7: Tree guard (wood post and rail)
TE8: Tree guard (wood post and wire)
PA4: Agroforestry plan
PA5: Moorland mapping plan
